OFFICIAL NOTICE - CHANGE OF JUDGE

In accordance with Chapter 7, Section 8 of the Rules Applying to Dog Shows, and with American Kennel Club approval, Patricia V. Trotter #6420 will judge the Morning Show Specialty classes, replacing Ms. Cynthia Woodward. Exhibitors affected by the judge change may withdraw their entry and receive a refund, provided notification is given to the Show Secretary no later than 30 minutes prior to conformation judging.

Dogs entered may arrive at any time before their class. Dogs may be excused after their class has been judged, if not required for further judging. Judges may take breaks at their discretion.

Directions To Show Site – Stanislaus County Fairgrounds, 900 N. Broadway, Turlock, CA 95380

- **FROM THE NORTH (e.g. Sacramento / Stockton):** Take Hwy 99 South to Turlock. Take exit 214 for Fulkerth Road. Use any lane to turn left onto Fulkerth Road. Turn right onto N. Golden State Blvd. Slight right onto N. Broadway. Fairgrounds will be on the right.
- **FROM THE SOUTH (e.g. Fresno):** Take Hwy 99 North to Turlock. Take exit 209 for Golden State Blvd. Continue onto S. Golden State Blvd. Slight right to stay on S. Golden State Blvd, merge onto S. First St. Continue onto W. Canal Dr. Turn right onto N. Broadway. Fairgrounds will be on the left.

 **Day of Show Parking – \$10.00 per day.** Parking will be just inside the main gate on grass section G1. Please be prepared to haul your equipment from the parking area to the ring area which may be a distance away. There are paved roadways. **Thursday Set-ups:** Exhibitors may place their set-ups on the grounds on Thursday during the afternoon from 2:00 PM onward.
