## Notice To Exhibitors

**CONDITIONAL, UNSIGNED, INCOMPLETE, or telephoned entries will not be accepted.** Entries without fees cannot be accepted. See Page 6 for information on emailed entries.

**ENTRIES NOT ON OFFICIAL AKC FORMS** or photocopies of entry forms without the **Agreement** and Instructions on the reverse side of the official AKC entry form are NOT ACCEPTABLE.

**PLEASE TYPE OR PRINT CLEARLY** using black or blue ink.

**OWNERS ARE RESPONSIBLE FOR ERRORS** on entry blanks, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors.

**CHANGES, ADDITIONS, OR CORRECTIONS** to entry forms must be received in writing prior to close of entries. Emailed changes are acceptable. Changes by telephone are not acceptable.

**RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE.** There will be a \$25.00 collection fee added to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis.

**AN AKC RECORDING FEE** of \$.50 first entry only and an AKC Event Service Fee of \$3.00 for first entry and \$3.50 for each additional entry will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial or Tracking Test. An AKC Recording Fee of \$3.50 will be required for each entry in any Licensed or Member Club Rally Trial. (Effective Jan 1, 2024)

**BITCHES IN SEASON** are not permitted to compete. If a female is withdrawn from competition for coming into season and the Trial Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. **A processing fee of \$8.00 per entry will be retained.** A signed veterinarian's letter stating the bitch is in season must be provided as documentation with the request or within one week of the trial at the latest to receive a refund.

**ENTRY FEES WILL NOT BE REFUNDED** in event of errors or cancellation of entries after the published closing date, nor in the event a dog is absent, disqualified, sick, lame, excused by the Veterinarian or Judge, or barred from competition by the Trial Committee.

**THE WELL-BEING OF DOGS** and participants is of paramount importance. If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fee(s) will be made. **DO NOT LEAVE ANIMALS IN A HOT VEHICLE.**

**RECEIPT OF ENTRY.** An emailed acknowledgement will be sent upon receipt of entry to the email address listed on the entry form. If exhibitor does not hear within a reasonable time, please contact the Trial Secretary before closing date.

**THE JUDGING SCHEDULE** with armband assignment will be sent to the email address on the Official AKC entry form approximately one week before the trial. If the exhibitor wishes to have a **printed** schedule mailed, please request on the entry form.

**CONSULT JUDGING PROGRAM** for time of judging. Exhibitors are responsible for having their dogs at ringside when it is their turn to be judged. Dogs need to be at the trial only at scheduled time of judging and may leave immediately after unless required for further judging.

**DOGS MUST BE KEPT ON LEASH** except when being judged in the ring.

**THERE SHALL BE NO DRILLING** nor intensive or corrective training of dogs on the show grounds or premises.

**NO PROVISIONS** will be made for unentered dogs on the grounds.

**IN THE CASE OF A TIE** for any prize, any dog that is not present for a run-off will forfeit its rights to the prize.

**ALL AWARDS MUST BE CLAIMED THE DAY OF THE TRIAL. NONE WILL BE MAILED** or delivered. An exhibitor whose dog is eligible for an award must be present or appoint a representative to accept the award.

These events will be held on private property. Please be respectful of the owners and their home and business.

- Park in the lot designated as RV parking. Follow those signs. Do not park by the kennel buildings.
- Clean up after your dog(s). Dispose of dog waste in buckets specifically for that purpose. Please do not use the garbage bins for dog waste.
- Dispose of garbage in containers placed on the show grounds.
- Only solid-bottom crates and wire crates with plastic trays are allowed in the covered arena where the rings are located. No Ex-Pens are allowed in the covered arena.
- Exhibitors may also place setups on the Lake Lawn area near by. All crates, mats or anything with a solid bottom must be pulled off the lawn at the end of the day. Nothing should be left on the lawn overnight.
- Do not allow your dog(s) to dig at the lawn or artificial turf areas.



Rally Championship points will be recorded for dogs earning a score of 91 or better in the Rally Advanced B, Rally Excellent B and Rally Master classes. A dog must earn a total of 300 points, with a minimum of 150 points from the Master class. Additionally, the dog must receive qualifying scores in Advanced B, Excellent B and the Master class on the same day at the same trial at 20 separate licensed or member rally trials.
