- *Compete in Open B and Utility B at all three of the trials identified as an AKC regional competition.*
- *Have a cumulative score obtained from the dog's participation in Open B and Utility B at the regional competition.*
- *Be ranked from highest to lowest based on their cumulative score with 1200 points being a perfect score.*
- *Qualify by cumulative score as one of the top four at one regional competition for an invitation to the National Obedience Championship.*

Obedience Class Information

Exhibitors must specify their dog's obedience jump height on entry form for classes with jumps.

Dogs will be separated by jump height and run in **ASCENDING order starting at 4"**.

Dogs without jump heights on entry form will be judged at the end of the class.

Non-Regular Obedience Classes are offered as listed below. See Page 3 for entry fees.

- **VETERANS**, offered Friday and Saturday only. The Veterans class will be for dogs that have an obedience title and are at least 7 years old on the date of the trial. The exercises will be performed and judged as in the Novice class.
- **OBEEDIENCE BRACE**, offered Saturday only. For two dogs (including dogs listed with AKC Canine Partners) of similar height at the withers that are eligible under these regulations and capable of performing the Novice exercises. The dogs need not be owned by the same person but will be handled by one handler. Dogs may be shown unattached or coupled. A separate official entry form must be completed in full for each dog entered, please send entry forms together. Either or both dogs in Brace may be entered in another class or classes.

Obedience Trial Prizes

Qualifying scores are required for prizes in the Regular, Preferred and Optional Titling classes.

Qualifying scores are not required in Non-Regular classes.

A Dark Green Qualifying Score Ribbon will be awarded to each dog with a qualifying score in Regular, Preferred, and Optional Titling Obedience classes.

Exhibitors must specify the dog's rally jump height for Advanced, Excellent, Master classes.

Rally classes with jumps will be run in **ASCENDING order starting with 4"**.

Rally ring size to be 40' x 50'.

The Non-Regular Rally Classes listed below are offered all three days.

- **RALLY PAIRS NOVICE.** Rally Pairs class consists of competition by one handler working two dogs at one time through a rally course. An official entry form must be completed for each dog. Please send entry forms together. See Page 3 for entry fees.
- **RALLY TEAM NOVICE, RALLY TEAM INTERMEDIATE, RALLY TEAM ADVANCED.** Rally Team is for any four dogs that are eligible. Five dogs may be entered, one to be considered an alternate for which no entry fee will be required. The same four dogs will perform all exercises. All team members will run the course individually, with the team time running continuously. For Advanced, the jump height will be based on the smallest dog on each competing team. No dog may be entered on more than one team. However, one person may handle more than one dog on a Team, as Rally Team is like a relay with one dog going after another. A separate entry form must be completed in full for each dog entered. When entering please designate a TEAM NAME on each entry form to allow for catalog numbering. See Page 3 for entry fees.

Notice To Exhibitors

The American Kennel Club Rules and Regulations will govern these Trials. Exhibitors must make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany this Trial Premium list.

ENTRIES CLOSE ON AUGUST 5, 2026 AT 9:00 PM (PDT). Fees must accompany entries. Canadian Exhibitors MUST make all checks and/or money orders payable in U.S. funds. All checks and money orders should be made payable to Mount Bachelor Kennel Club or MBKC. See Page 3 for mailing address and information on emailed entries.

TELEPHONE, TELEGRAPH AND UNSIGNED ENTRIES CANNOT BE ACCEPTED and will be returned. Entries not on an Official AKC Entry Forms and without the Agreement and Rules on the reverse side are NOT ACCEPTABLE. The Club assumes no responsibility for wrong or incomplete information given on the entry blank by the owner or the owner's agent, or if the dog is entered in a class in which it is not eligible to compete. THE RESPONSIBILITY FOR THE COMPLETENESS OF ANY ENTRY RESTS SOLELY WITH THE ENTRANT.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. The Secretary will make every effort to find all duplicate entries, but if entry has been processed, no refund will be made. There is NO REFUND for duplicate entries or over-payments.

If, because of riots, civil disturbances, loss of site, fire, Act of God, act of a public enemy, strikes, extreme weather conditions (including but not limited to extreme heat, floods, snow storms, hurricanes, lightning, or earthquakes), or any other acts beyond the control of the management, it is impossible to open or complete the trial, no refunds of entry fees will be made.

BITCHES COMING INTO SEASON after the closing date for entries may have the entry fee refunded less \$6.00 per class upon written verification of a Veterinarian before the start of judging of the Trial on the day of the Trial the dog was entered.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor or agent may result in their being put on a CASH ONLY basis

THIS CLUB DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.

JUDGING: The judging will start promptly as specified in entry confirmation. Dogs may arrive anytime prior to their time of judging, and may leave immediately thereafter, unless required for further judging. The Club will not be responsible and are not obligated to furnish any service for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of their dogs in the judging ring. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class; it is not the responsibility of the ring steward to locate any dog, its owner or its agent when the dog's presence is needed in the judging ring. Judges will NOT wait for any dog holding up a class.

ACKNOWLEDGMENTS: Entries will be acknowledged after entries close, with acknowledgment and judging program sent to email address on entry. Should exhibitors NOT receive an acknowledgment within a reasonable time, contact the Trial Secretary.

DOGS IN UNVENTILATED VEHICLES: All persons attending this dog event hereby waive any claim for damages against Mt Bachelor Kennel Club or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.

LOSS OR DAMAGE: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs or exhibitors participating in this Trial. The welfare of an Exhibitor's child is assumed to be the responsibility of the Exhibitor.

CHILDREN: It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the trial. Parents are expected to accompany and supervise their children at all times.

AWARDS: Trophies and prizes will be awarded at the trial. No Award will be mailed.

LIABILITY: Mount Bachelor Kennel Club will do all possible to ensure the welfare of dogs and exhibitors alike, but do not assume responsibility nor liability in the event of an accident or misfortune to either dogs, exhibitors or spectators at these events. 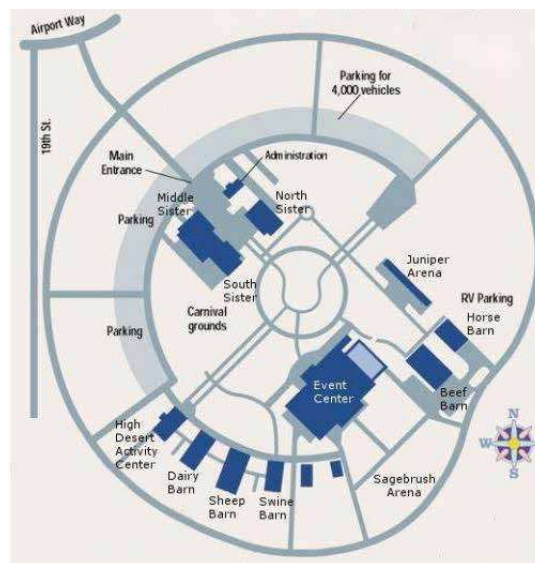
