The Reserve Winners Dog and Reserve Winners Bitch at a Specialty will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winners' sex totals at least TWICE the number required for a five-point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners.

Neutered dogs and spayed bitches are allowed to compete in single-entry, non-regular classes at this specialty. Full AKC registration is required (not limited registration).

BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed or Variety competition: Dogs that are Champions of Record, or Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where a dog completed the requirements for a championship according to the owners' records. Winners of the above Non-Regular Classes may also compete in the Best of Breed Competition, provided that they are undefeated in any classes at this show.

SPECIAL AWARDS

Owner-Handled Best of Breed. This event qualifies for the AKC National Owner-Handled Series (NOHS). The exhibitor MUST check the Owner-Handled checkbox on the entry form to be eligible. See Page 7.

Best Veteran Dog & Best Veteran Bitch, judged from the winners of the Veteran classes.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

Stud Dog Class. For Dogs and two of their Get. Stud Dogs must be entered in Stud Dog Class and must be shown in the ring with their Get. Get only to be judged, based upon the merits of the Get. The get must be entered in one of the Regular or Non-Regular single dog conformation classes above.

Brood Bitch Class. Same as Stud Dog, substitute "Brood Bitch" for "Stud Dog" and "produce" for "get."

Brace Class. For two Newfoundlands with one common owner, to be shown by one or two handlers.

Maturity. Three dogs/bitches from a three generation pedigree, judged as a unit. See Page 7.

Neutered dogs and spayed bitches are allowed to compete in Stud Dog, Brood Bitch, Brace, and Maturity.

As the judge's decision in the Stud Dog, Brood Bitch, Brace and Maturity classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged First in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.

Maturity Class

This is a non-regular conformation class involving multiple-dog entries. Entry will be as one unit and is comprised of one dog or bitch from each generation of a three-generation pedigree. Unit to be judged on the merits of all three generations. Two of the three Newfoundlands must be entered in a regular or non-regular class at this specialty. Neutered and spayed are eligible. Dogs need not be owned by the same person(s).

National Owner-Handled Series



**REMEMBER TO CHECK THE “OWNER-HANDLED”

The purpose of the AKC National Owner-Handled Series (NOHS) is to recognize and showcase the quality dogs being exhibited by owner/handlers that are not professional handlers.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS.

The handler must be an owner of record according to AKC's records as of the date of the show.

Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog.

Professional handlers, household members and current assistants to professional handlers in conformation are not eligible to exhibit in this competition.

A professional handler is defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any show during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age and amateur tatus requirements) may compete in NOHS.

Eligibility restrictions apply to all members of the same household.

Dogs must be handled by an eligible owner/handler for the NOHS throughout the breed level (all classes, Winners, and Best of Breed) competition. Additionally, dogs must be handled by an eligible owner/handler throughout the NOHS competition (Group and Best in Show). Any person may exhibit the dog in the regular Group/BIS competitions.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

Sweepstakes

Open to any Newfoundland six months of age and under **twenty-four (24) months** of age. All dogs/bitches must also be entered in a Regular class at this Specialty Show. Indicate "Sweepstakes" (stating age/class) in the space for "Additional Classes". Sweepstakes will be judged prior to the Regular classes.

CLASS TRANSFERS ARE ALLOWED in Obedience and Rally. Transfers may be approved provided the class is scheduled, the judge is available, and the class has not reached its limit. Transfer requests will be accepted in writing (or email) to the Trial Secretary from close of entries until the day **prior** to the trial. Please confirm receipt of request. Transfers on the day of the trial must be presented in writing at the Trial Secretary desk at least 30 minutes prior to the start of the trial.

BITCHES IN SEASON are not permitted to compete in Obedience or Rally Trial classes. If a female is withdrawn from competition for coming into season and the Event Secretary is notified no later than ½ hour prior to the start of the first class, then the club will refund the entry fee. A processing fee of \$10.00 per entry will be retained.

Four-to-Six Month Puppy Competition

Judge: Mrs. Eva E. Berg

ENTRY AND ELIGIBILITY

- ◆ Open to all Newfoundland puppies that are (4) months & under (6) six months of age on the day of the event. The class is not divided by sex.
- ◆ An AKC registration number or litter number will be required for entries of an AKC recognized breed, Miscellaneous or FSS breed.
- ◆ A foreign born dog may enter this class if they are registered in the country of origin.
- ◆ Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized.
- ◆ Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "**Exhibition Only**" in the Four-to-Six Month Competition. "Exhibition Only" entries are not eligible to earn awards in this competition. Please mark "Exhibition Only" on the entry form.
- ◆ Dogs that are owned or co-owned by the forenamed a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- ◆ Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.
- ◆ Exhibition Only entries may NOT be changed to be eligible to compete for awards after the close of entries.
- ◆ Use the Official AKC Entry Form from the premium list to enter. Indicate "4-6 mo. Puppy" on the entry form under "Class". The entry fee is \$27.00.

JUDGING

- ◆ All applicable rules found in Rules Applying to Dog Shows will govern the conduct of this competition unless these regulations state otherwise. AKC Rules in Dealing with Misconduct will be applicable to any person and dog entered at this competition.
- ◆ Exhibitors should open their dog's mouth for examination.
- ◆ No dog is to be judged if it is brought into the ring bandaged, taped, glued or stitched anywhere including ears or tail. These dogs must be excused from judging but, at the judge's discretion, may return to be judged after the tape or bandage is removed.
- ◆ Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this Best Beginner Puppy in Breed.
- ◆ The judge will select Best Four-to-Six Month Puppy and BOS Four-to-Six Month Puppy. Exhibition Only entries will be judged as all other entries (examined and gaited) but may not be considered for BOB/BOS.

Grounds Information

- ◆ ***Exhibitors and Handlers*** - If your dog soils the parking lot, show grounds or a ring, it is your responsibility to clean it up. Please police your grooming area before leaving the show grounds. By signing the entry form at this dog show you are agreeing that clean-up is your responsibility. Violators may be subject to a bench show committee hearing. Exhibitors, please, if you see an area that has not been cleaned up, notify a Club Member immediately. Thank you.
- ◆ NO GROOMING SETUP OR X-PENS IN THE RINGSIDE WAITING AREAS OR IN THE BUILDING.
- ◆ CRATES ALLOWED AT RINGSIDE ONLY WHEN YOUR BREED IS IN THE RING.
- ◆ PLEASE SET UP BY THE RING ONLY 15 MINUTES PRIOR AND REMOVE YOUR TEMPORARY SETUP EQUIPMENT AND DOGS AFTER BREED TIMES TO ALLOW SPACE FOR OTHER EXHIBITORS TO SETUP DURING THEIR BREED TIMES.
- ◆ NO WHEELS ALLOWED ON THE GRASS IN THE OUTDOOR RINGS.

Notice To Exhibitors

1. Owners are responsible for errors on entry blanks and for entering the same dog twice. Entry fees will not be refunded in the event of errors or cancellation of entries received after published closing date, nor in the event that a dog is absent, disqualified, lame, excused by the Veterinarian or Judge, or barred from competition by the Show Committee. Due to cost of processing, no refunds less than \$4.00 will be made.
2. If, because of riots, civil disturbances or other acts beyond the control of the Management it is impossible to open or complete the show, no refund of entries will be made. Extreme weather conditions, such as, but not limited to hurricanes, lightning, extreme heat or earthquakes, must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made.
3. **AKC FEES.** The American Kennel Club requires each show-giving club to collect the following fees on each recordable entry and forward to AKC. Each first entry of a dog in conformation and obedience includes \$.50 AKC Recording Fee and \$3.00 Event Service Fee. Each additional entry of same dog in conformation/obedience includes \$3.50 Event Service Fee. Each entry in a Rally Trial includes \$3.50 AKC Recording Fee. Each entry in Four-to-Six Month Puppy includes \$2.00 AKC Recording Fee. No fees are collected for sweepstakes, junior showmanship or non-regular classes. The fees listed in the Entry Fees section already include these fees.
4. Entries must be made on Official AKC Entry Forms, or photocopies with the agreement and rules on the reverse.
5. Dogs need to be at the show at scheduled time of judging and may leave immediately after being judged unless needed for further judging.
6. Dogs must be ready for judging. The Club and/or its Show Secretary will not be responsible for and are not obligated to provide any service for notifying exhibitors or their agents of class judging. Judges need not wait for dogs holding up class judging.
7. Dogs, which according to their owners' records have completed the requirements for a championship after the closing of entries for the show, but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made at least one-half hour prior to the start of any regular conformation judging at the show.
8. No dogs will be allowed in the show area except those entered in the show. There are no provisions for unentered dogs.
9. Please note that **NO PUPPIES UNDER SIX MONTHS** are permitted on the show grounds, except those entered in the 4-6 Month Puppy Competition.
10. There shall be no drilling nor intensive training of dogs on the show grounds.
11. Confirmation of entry and schedule of judging time will be sent to the address on the Official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule within seven days of the show, please contact the Show Secretary.
12. An **AGENT** is a person 18 years or older, other than an owner or co-owner, designated by the owner or co-owner to be handler of, and responsible for, the dog at the show. Agents' names may be followed by the initials which represent their AKC-recognized professional group affiliation or certification. Persons seeking the services of such an agent should familiarize themselves with the requirements for professional group membership or certifications.
13. Trophies and prizes will be awarded in the judging ring to the person exhibiting the dog, who will be considered the owner or his agent. All claims for trophies must be made in the judging ring before the completion of judging. No trophies will be mailed.
14. **COVID-19.** All attendees will follow CDC Guidelines regarding best practice measures and will adhere to any state, local or facility protocols pertaining to COVID-19 that may be in effect on the day of the event.
15. **DOGS IN VEHICLES DURING HOT WEATHER** - All persons attending this dog show hereby waive any claim for damages against NCA, its Regional Club, Wine Country Kennel Club, and/or any of their members, in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.
16. **EXHIBITORS SHOULD FOLLOW THEIR VETERINARIANS' RECOMMENDATIONS** to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Working Group

General Appearance

The Newfoundland is a sweet-dispositioned dog that acts neither dull nor ill-tempered. He is a devoted companion. A multipurpose dog, at home on land and in water, the Newfoundland is capable of draft work and possesses natural lifesaving abilities. The Newfoundland is a large, heavily coated, well balanced dog that is deep-bodied, heavily boned, muscular, and strong. A good specimen of the breed has dignity and proud head carriage. The following description is that of the ideal Newfoundland. Any deviation from this ideal is to be penalized to the extent of the deviation. Structural and movement faults common to all working dogs are as undesirable in the Newfoundland as in any other breed, even though they are not specifically mentioned herein.

Size, Proportion, Substance

Average height for adult dogs is 28 inches, for adult bitches, 26 inches. Approximate weight of adult dogs ranges from 130 to 150 pounds, adult bitches from 100 to 120 pounds. The dog's appearance is more massive throughout than the bitch's. Large size is desirable, but never at the expense of balance, structure, and correct gait. The Newfoundland is slightly longer than tall when measured from the point of shoulder to point of buttocks and from withers to ground. He is a dog of considerable substance which is determined by spring of rib, strong muscle, and heavy bone.

Head

The head is massive, with a broad skull, slightly arched crown, and strongly developed occipital bone. Cheeks are well developed. Eyes are dark brown. (Browns and Grays may have lighter eyes and should be penalized only to the extent that color affects expression.) They are relatively small, deep-set, and spaced wide apart. Eyelids fit closely with no inversion. Ears are relatively small and triangular with rounded tips. They are set on the skull level with, or slightly above, the brow and lie close to the head. When the ear is brought forward, it reaches to the inner corner of the eye on the same side. Expression is soft and reflects the characteristics of the breed: benevolence, intelligence, and dignity. Forehead and face are smooth and free of wrinkles. Slope of the stop is moderate but, because of the well developed brow, it may appear abrupt in profile. The muzzle is clean-cut, broad throughout its length, and deep. Depth and length are approximately equal, the length from tip of nose to stop being less than that from stop to occiput. The top of the muzzle is rounded, and the bridge, in profile, is straight or only slightly arched. Teeth meet in a scissors or level bite. Dropped lower incisors, in an otherwise normal bite, are not indicative of a skeletal malocclusion and should be considered only a minor deviation.

Neck, Topline, Body

The neck is strong and well set on the shoulders and is long enough for proud head carriage. The back is strong, broad, and muscular and is level from just behind the withers to the croup. The chest is full and deep with the brisket reaching at least down to the elbows. Ribs are well sprung, with the anterior third of the rib cage tapered to allow elbow clearance. The flank is deep. The croup is broad and slopes slightly. Tail--Tail set follows the natural line of the croup. The tail is broad at the base and strong. It has no kinks, and distal bone reaches to the hock. When the dog is standing relaxed, its tail hangs straight or with a slight curve at the end. When the dog is in motion or excited, the tail is carried out, but it does not curl over the back.

Forequarters

Shoulders are muscular and well laid back. Elbows lie directly below the highest point of the withers. Forelegs are muscular, heavily boned, straight, and parallel to each other, and the elbows point directly to the rear. The distance from elbow to ground equals about half the dog's height. Pasterns are strong and slightly sloping. Feet are proportionate to the body in size, webbed, and cat foot in type. Dewclaws may be removed.

Hindquarters

The rear assembly is powerful, muscular, and heavily boned. Viewed from the rear, the legs are straight and parallel. Viewed from the side, the thighs are broad and fairly long. Stifles and hocks are well bent and the line from hock to ground is perpendicular. Hocks are well let down. Hind feet are similar to the front feet. Dewclaws should be removed.

Coat

The adult Newfoundland has a flat, water-resistant, double coat that tends to fall back into place when rubbed against the nap. The outer coat is coarse, moderately long, and full, either straight or with a wave. The undercoat is soft and dense, although it is often less dense during the summer months or in warmer climates. Hair on the face and muzzle is short and fine. The backs of the legs are feathered all the way down. The tail is covered with long dense hair. Excess hair may be trimmed for neatness. Whiskers need not be trimmed.

Color

Color is secondary to type, structure, and soundness. Recognized Newfoundland colors are black, brown, gray, and white and black.

Solid Colors--Blacks, Browns, and Grays may appear as solid colors or solid colors with white at any, some, or all, of the following locations: chin, chest, toes, and tip of tail. Any amount of white found at these locations is typical and is not penalized. Also typical are a tinge of bronze on a black or gray coat and lighter furnishings on a brown or gray coat.

Landseer--White base coat with black markings. Typically, the head is solid black, or black with white on the muzzle, with or without a blaze. There is a separate black saddle and black on the rump extending onto a white tail.

Markings, on either Solid Colors or Landseers, might deviate considerably from those described and should be penalized only to the extent of the deviation. Clear white or white with minimal ticking is preferred.

Beauty of markings should be considered only when comparing dogs of otherwise comparable quality and never at the expense of type, structure and soundness.

Disqualifications-- Any colors or combinations of colors not specifically described are disqualified.

Gait

The Newfoundland in motion has good reach, strong drive, and gives the impression of effortless power. His gait is smooth and rhythmic, covering the maximum amount of ground with the minimum number of steps. Forelegs and hind legs travel straight forward. As the dog's speed increases, the legs tend toward single tracking. When moving, a slight roll of the skin is characteristic of the breed. Essential to good movement is the balance of correct front and rear assemblies.

Temperament

Sweetness of temperament is the hallmark of the Newfoundland; this is the most important single characteristic of the breed.

DISQUALIFICATIONS

Any colors or combinations of colors not specifically described are disqualified.

Obedience Trial Championship

Obedience Trial Championship points will be recorded for those dogs that have earned a first, second, third or fourth place ribbon competing in the Open B or Utility B class, according to the schedule of points established by the AKC Board of Directors. When counting the number of eligible dogs in competition, a dog that is disqualified or excused from the ring by the judge will not be included.

One (1) Championship point will be recorded for those dogs that earn a qualifying score of 197 or better in the Open B or Utility B class, if they did not earn points based on the Point Schedule.

Requirements for the Obedience Trial Champion are as follows. The dog must have won:
1. 100 points; 2. A first place in Utility B with at least three dogs in competition; 3. A first place in Open B with at least five dogs in competition; 4. An additional first place under the conditions of 2 or 3 above; 5. All three first places under three different judges. Only one of the required first places may have been won at a specialty Show or a Junior Obedience Showcase.

The letters OTCH will be followed by a numeric designation indicating the number of times a dog has met the requirements of the OTCH title as defined in these regulations (OTCH2, OTCH3, OTCH4, etc).
